# **Judges Offer Contest Advice**

With the **2025 Writing Contest** nearing its submission period, we turn to last year's judges for advice about what makes winning entries.

Without judges, there can be no writing contests. We appreciate these members who volunteered to judge last year's GCWA Writing Contest. For the *Fiction* category: **Ginger Wakem**. **Sheryl Stillman** and **Lori Swick**; *Non-Fiction*: **John Granatino**, **Claudia Volkman** and **Jan Porter**, and for *Poetry*: **Patti Walsh**, **Mary Lou Williams** and **Jeanne Meeks**.

## **Universal Advice**

Every judge emphasized strictly adhering to guidelines. While this sounds elementary, it echoes in every contest article I've read. This includes formatting and word count, as well as proper grammar, punctuation, and sentence structure. Contest instructions are not suggestions, they are imperatives. Entries that don't meet criteria are disqualified quickly. Jeanne suggests not submitting your piece is ready. "Make it your very best with having others critique your work and take their suggestions to heart," she says.

## **Study Previous Winning Entries**

Sheryl said studying past winners to see what worked improves her own entries. This includes understanding story framing, tone, arc, and quality. Contests have expectations about what makes a winning story. Reviewing previous winners can provide insight into what judges look for.

## Just Do It!

Most judges have also been contest entrants. All have encountered feelings of fear, inadequacy, or intimidation. Lori noted, "whether or not you win, it's always a win just to get your writing out into the world. Nothing happens with it until you do!" Mary Lou adds, "Don't be intimidated. You don't have to be a literary genius to have a chance at winning. The experience of competing is empowering. Your chances of winning are a lot better than your chances of winning the lottery."

# My book's journey with speed bumps, bruises, and Force Majeure

After nearly four years of plotting, writing, rewriting, editing, more editing, beta readers, searching for a publisher, working with a professional editor, and more editing ... my thriller novel <u>The Vulnerable</u>, an intricate Eco-thriller set in Massachusetts and Florida, will be coming out this spring!

Along the way, I was disrupted, disheartened, and reeling with PTSD from three category-four hurricanes: Ian, Helene, and Milton. Set back by a heart attack and two months of rehab. Delayed by three surgeries: Peripheral Iridotomy on both eyes for narrow-angle closure glaucoma, an emergency heart stent, and recently, long overdue, dual cataract surgery further complicated by glaucoma eye pressure; even as I write this piece with a patch over one eye!

Not surprisingly, I was rejected or ignored by large and midsize agented and non-agented publishers. But I learned from every submittal. After being solicited by several vanity publishers and aggressive and overpriced hybrids, I did a ton of due diligence on small indie press and other reputable hybrids that I passed on.

Finally, my selection and then my acceptance in January 2025 into an excellent, author-centric coop and fellowship of talented award-winning authors at Indies United Publishing House (IUPH). This was a pivotal moment in my literary journey. "The Vulnerable" is scheduled to be released in April. I hope to have my collection of short memoir stories, "Simpler Times in The Spindle City," published in late 2025.

For me, the work of finding a collaborative partner (which was exhaustive) is paying off. Perseverance and forging on past every obstacle were critical on my path to fulfill my aspiration of sharing my stories with a broader audience.

# **February Monthly Member Meeting Recap**

# **Editing Overview**

The February 15, 2025 meeting at the Cape Coral Library drew an audience of nearly 50, including nine new guests. Welcome to GCWA!

**Claudia Volkman,** GCWA member and owner of Creative Editorial Solutions shared the various forms of editing prior to publishing. Highlights are below. Click here for the Zoom recording.

**Developmental editing** is performed as the first draft is near or at completion. It is 'big picture' editing, and reviews the overall concept, and organization as well as the delivery of the message to the desired reader.

**Book doctoring** is a collaborative, hands-on type of editing where the editor may actually work with the author or make editorial changes to help clarify the writer's message.

**Content or Line Editing** occurs after revisions and is a line-by-line review for polishing of grammar, syntax, word choice, factual accuracy, and 'tightness' of the prose.

**Copy Editing** is a detailed editing for grammar, syntax, typos, and consistency of usage and formatting throughout the work. **Proofreading** is conducted after layout and typesetting. It is another layer of editing for grammar and punctuation. It also ensures, headers, footers, and other formatting are correct and consistent.

# **GCWA Writer Critique**

Debut open critiquing session, introduced by **Brian Devitt**, based on an established program in his writer's group in Philadelphia. GCWA members were invited to critique three 5,000 word works or excerpts submitted by our members. The three bold authors for this first critique session were **Rob Gilmore**, "Cannassett - The Space Port" (excerpt), **Laura Schueneman**, "How to Murder Your Man's Mistress" (excerpt), and **Richard Drummer**, "Blood Symphony."

During open critiques, Brian and Jeanne Meeks led members who read the works online. Emphasis was placed on what was good about the writing – what worked well, and then constructive suggestions for improvement. The discussion was active and positive. The program was well received and there was a consensus to make this a monthly part of the program for authors who wish feedback on short works. The suggestion was made that slightly shorter pieces might be more manageable.





